

These Terms of Service (“Terms”) govern your use of the VENTURELAND Web Site (“VENTURELAND Site”) and the VENTURELAND services (“Services”). These Terms apply to all users of the VENTURELAND Site and Services. By using the VENTURELAND Site or Services, you agree to these Terms.

ELIGIBILITY

You must be at least 18 years old to use the VENTURELAND Site or the Services.

ADDITIONAL TERMS

Some of our Services have additional terms and conditions (“Additional Terms”). When Additional Terms apply to a Service, we’ll make them available for you to read through. By using the Services, you agree to the Additional Terms.

ACCEPTABLE USE OF THE VENTURELAND SITE AND SERVICES
